



Cookies and Privacy Notice Policy

What are Cookies?

Cookies are small files which are stored on your computer. They are designed to hold a modest amount of data specific to your website visit on our site.

Cookies help to improve your visit to our website by helping with the following:

- Remembering settings, so you don't have to keep re-entering them whenever you visit a new page
- Remembering information you've given (e.g. your postcode), so you don't need to keep entering it
- Measuring how you use the website, so we can make sure it meets your needs

Please note that cookies can't harm your computer and we do not store personally identifiable information in cookies we use on this website.

We're giving you this information as part of our initiative to comply with UK legislation, and to make sure we're honest and clear about your privacy when using our website.

Please be assured that we're working on a number of other privacy and cookie-related improvements to the website.

The Cookies we use:

General website cookies

This website is built using Microsoft's ASP.Net web technologies, as part of that we use the built-in session cookie (ASP.Net_SessionID) to manage your session. When you navigate to the site, the server establishes a unique session that last for the duration of your visit.

Measuring website usage - Google Analytics

Google Analytics uses cookies to define user sessions, as well as to provide a number of key features in the Google Analytics reports. Google Analytics sets or updates cookies only to collect data required for the reports. Additionally, Google Analytics uses only first-party cookies. This means that all cookies set by Google Analytics for your domain send data only to the servers for your domain. This effectively makes Google Analytics cookies the personal property of this website domain, and the data cannot be altered or retrieved by any service on another domain.

The following table lists the type of information that is obtained via Google Analytics cookies and used in Analytics reports.

Once the cookies are set/updated on the web browser, the data they contain that is required for reporting purposes is sent to the Analytics servers in the GIF Request URL via the `utmcc` parameter.

Cookies Set By Google Analytics

Google Analytics sets the following cookies as described in the table below. A default configuration and use of Google Analytics sets only the first 4 cookies in the table.

Air Bearings Limited respects the privacy of all those who visit our Site and use our online services and we collect information from and about our users to be used to improve the service we offer. Information Collection and Use

For a better experience, while using our website, we may require you to provide us with certain personally identifiable information, including but not limited to your name, email address, phone number, and postal address. The information that we collect will be used to contact or identify you, for the purpose of your request and/or enquiry. For example:

1. Non-personally-identifiable information:

As a standard practise, Air Bearings Limited assigns a random number to each user for anonymously tracking content preferences and traffic patterns. This random number lets us keep track of "how many" times users are doing specific things - like visiting our site each month - without really knowing who those users are (unless they specifically tell us). We analyse this data for trends and statistics, such as which parts of our site users are visiting and how long they spend there. We also gather information about what users are searching for. We use all this information in order to improve our content, plan site enhancements, and measure overall site effectiveness.

2. Personally identifiable information:

General: In certain areas of this Site, we require that you provide us with personally-identifiable information, in order to be able to use that portion or those portions of this Site.

If you submit a request for more information from us, the information you submit will only be used by Air Bearings Limited. Our lists are private and are never sold to any third parties.

Whereby you submit an application for a vacancy to ABL via email for recruitment purposes, we will therefore collect this data from you. This personal data may include:

- Your name
- Address and contact details (including email address and telephone number)
- Details of your qualifications, skills, experience and employment history
- Information about your current level of remuneration, including benefit entitlements
- Information about your entitlement to work in the UK
- Any other additional information provided by you in the context of the recruitment and selection process

This information may be collected from you a variety of ways. For example, data might be contained in application forms, CVs or resumes, obtained from your passport or other identity documents, or collected through interviews.

We may also collect personal data about you from third parties, such as references supplied by former employer. We will only seek information from third parties only once a job offer to you has been made and will inform you that it is doing so.

Data will be stored in a range of different places, including on your application record, in HR management systems and on other IT systems (including email).

Why do we process this personal data?

ABL needs to process data to take steps to enter into a contract with you.

In some cases, the company needs to process data to ensure that it is complying with its legal obligations. For example, it is required to check a successful applicant's eligibility to work in the UK before employment starts.

ABL has a legitimate interest in processing personal data during the recruitment process and for keeping records of the process. Processing data from job applicants allows us to manage the recruitment process, assess and confirm a candidate's suitability for employment and decide to whom to offer a job. Company may also need to process data from job applicants to respond to and defend against legal claims.

ABL will not use your data for any purpose other than the recruitment exercise for which you have applied.

Who has access to your data?:

Your information will be shared internally for the purposes of the recruitment exercise. The company will not share your data with third parties, unless your application for employment is successful and it makes you an offer of employment.

Your data may be transferred to countries outside the European Economic Area (EEA) for recruitment purposes e.g. request for employment references.

We are required to confirm the identity of our staff, their right to work in the United Kingdom and seek assurance as to their trustworthiness, integrity and reliability. To do this, we may therefore require you to provide the following:

- proof of your identity –e.g. passport, driving license, and or birth certificate. We will take copies of these
- proof of address –We will take copies of these
- proof of your qualifications where relevant to the job
- references - we will contact your referees directly using the details you provide in your application, to obtain references from your former employers

If we make a final offer, we will also ask you for the following:

- bank details – to process salary payments
- Employee Information form: to gather key information we need from you, such as contact details, National insurance numbers etc.
- emergency contact details – so we know who to contact in case you have an emergency at work
- membership of a pension scheme

(More detail on what we will request from you following an offer, is outlined in our '**GDPR Data Privacy Policy (Employment)**' which is available upon request and where applicable.

How long do we keep your data for?

If your application for employment is unsuccessful, we will hold your data on file for 12 months (or for a longer period as and if agreed by you) after the end of the relevant recruitment process. At the end of that period, your data is either deleted or destroyed.

If your application for employment is successful, personal data gathered during the recruitment process will be transferred to your personnel file and retained during your employment. The periods for which your data will be held will be for as long as required for employment purposes.

Your rights:

As a data subject, you have a number of rights. You can:

- access and obtain a copy of your data on request
- require the company to change incorrect or incomplete data
- require the company to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing
- object to the processing of your data where the company is relying on its legitimate interests as the legal ground for processing
- ask the company to stop processing data for a period if data is inaccurate or there is a dispute about whether or not your interests override the company's legitimate grounds for processing data
